Starting from October 1st, 2024 the terms of the Child Allowance System will change. **This is an important** notification, please read through to the end including the reverse page.

O Details of revision:

- (1) There will no long have an annual income limit.
- (2) The payment period will be extended to the end of High School age group.
- (3) The payment from the third child will increase.
- (4) The scope of calculation for multiple children will be extended until the university age group².
- (5) The payment will change from 3 times a year to 6 times year (months of April, June, August, October, December and February)

- *If you have any child that doesn't live in the same address, it could be necessary to fill out other documents, so please consult the Children Affairs Division (*Kodomo-ka*) of the Town Hall beforehand.
- **For those who didn't receive any other forms (only this notification), at principle will not be necessary to do any procedure. But in some cases (for example when the child lives in a different address) it will not be possible to confirm the necessity of the procedure or not. Go to the Oizumi Town Hall, 3rd floor, the Children Affairs Division (counter number 24) (Between the hours of 8:30AM to 5:15PM, except weekends and national holidays) and fill out the necessary application forms or send them by mail.

X From September 09th (Mon) until September 13th (Fri), the responsible counter will be open until 7:00PM.

OApplication deadline:

Until September 30th, 2024.

For those who have done the application until September 30th will receive the payment starting from December (from the months of October and November)

*If there's any mistake in the application form or lack of necessary documents, the payment can be postponed to January 2025.

*Due to the grace period provided by the law, doing the necessary procedure by March 2025, it is possible to receive the retroactive payment from October 2024.
